

# 'Plugging Into Nashville' Attendee Terms & Conditions

*These are the Terms & Conditions that apply to INDIE CONNECT, Inc. (the "producer") clients that attend 'Plugging Into Nashville' events produced and presented by INDIE CONNECT. Prior to your registration, you must acknowledge and accept the Terms & Conditions contained herein. Should you not wish to accept the Terms & Conditions you should not register. Submission of a registration is regarded as affirmation of your acceptance of the Event Terms & Conditions.*

**Payments:** All bookings made prior to the event must be paid in full to guarantee registration. Once payment has been received, an email confirmation and a receipted invoice will be sent. If payment is not made at the time of booking, registration will be provisional.

**Early Bird Rate:** In order to qualify for any "early bird" rates or discounts, booking and payment must be received before the deadline date listed in the event marketing material.

**Cancellation Policy:** Our cancellation policy allows for a refund, less a 20% administrative charge, for cancellations received in writing at least seven (7) days prior to the event date. No refunds will be made after this date. Instead, a credit will be immediately issued for up to one (1) year to attend another INDIE CONNECT program of the registrant's choice. Attendee substitutions may be made up to 72 hours prior to the first event date. If a registered delegate does not cancel and fails to attend the event, this will be treated as a cancellation and no refund or credit will be issued.

**Adjustment of Registration Fees:** After a client's registration is completed, INDIE CONNECT reserves the right to review the information provided by the delegate and adjust the registration ticket type and fee if it is found that the information provided by the attendee has been misrepresented, false or incorrect. Any adjustment to fees will be charged directly to the payment method on file.

**Speakers:** Views expressed by speakers are their own. INDIE CONNECT cannot accept liability for advice given, or views expressed, by any speaker at the event or in any material provided to attendees.

**Visa Requirements / Invitation Letter:** It is the attendee's sole responsibility to take care of visa requirements. If you require an entry visa, you must allow sufficient time for the visa application procedure. Your registration details might be shared with the immigration authorities to assist in the immigration process. However, INDIE CONNECT will not contact embassies and consulates on your behalf. **Credentials:** INDIE CONNECT-issued credentials are the sole property of the event Organizer and must be surrendered upon demand to INDIE CONNECT representatives. INDIE CONNECT-issued credentials must be

prominently displayed while at the event or designated off-site activities. False certification of an individual as an attendee or exhibitor's representative, misuse of an attendee badge, or any other method or device used to assist unauthorized personnel to gain admittance to the event and/or exhibit floor, will be just cause for expelling the attendee and his representative(s) from the event and/or banning them from future entrance into the event. This would also warrant the removal of the exhibitor's booth from the floor without obligation on the part of INDIE CONNECT for refund of any fees. The attendee, exhibitor, his/her employees and agents, and anyone claiming to be in the event through the attendee, waives any rights or claims for damages arising out of the enforcement of this rule.

**Admittance:** In its sole discretion and without refund, INDIE CONNECT reserves the right to refuse admittance to or expel from the event anyone that it determines is behaving in a manner that could be disruptive to the event or any other attendee.

**Indemnity:** In consideration of being allowed to register for, and participate in the event, I hereby warrant and represent that I am age 18 or above and freely waive, release from liability, assume all risks, and covenant not to sue INDIE CONNECT or its members, employees, board members, agents, or volunteers for any expense, loss, damage, personal injury, including loss of life, disability, property damage, or property theft or actions of any kind that I may hereafter suffer or sustain before, during, or after the event, unless said expense, loss, damage, personal injury, including loss of life, disability, property damage or property theft or actions of any kind is caused by the sole, gross negligence of INDIE CONNECT. This Liability Waiver and Release is specifically binding upon my heirs and assigns and is knowingly given.

**Disclaimer:** INDIE CONNECT may at any time, with or without giving notice, in its absolute discretion and without giving any reason, change, cancel or postpone the event, change its venue or any of the other published particulars, or withdraw any invitation to attend. In any case, neither INDIE CONNECT nor any of its officers, employees, agents, members or representatives shall be liable for any loss, liability, damage or expense suffered or incurred by any person, nor will they return any money paid to them in connection with the event unless they are satisfied not only that the money in question remains under their control, but also that the person who paid it has been unfairly prejudiced, about which the decision shall be in their sole and unfettered discretion and, when announced, final and conclusive.

**Force Majeure:** INDIE CONNECT shall not be held responsible for any delay or failure in performance of its obligations hereunder to the extent such delay or failure is caused by fire, flood, strike, civil, governmental or military

authority, acts of God, acts of terrorism, acts of war, epidemics, the availability of the Venue or other similar causes beyond its reasonable control and without the fault or negligence of INDIE CONNECT or its subcontractors. For one or more of such reasons, INDIE CONNECT may postpone, reschedule or cancel the event without liability on the part of INDIE CONNECT. In the event the event cannot be held or is postponed pursuant to this section, INDIE CONNECT shall not be liable to attendee for any damages, costs, or losses incurred, such as transportation costs, accommodations costs, or financial losses. INDIE CONNECT will review refund and/or fee transfer requests, submitted in writing, for approval on a situational basis.

General: INDIE CONNECT reserves the right to change, amend, add or remove any of the above Terms & Conditions in its sole discretion and without prior notice. If one or more of the conditions outlined in these Terms & Conditions should become invalid, the remaining conditions will continue to be valid and apply.
